
Determination Number 1 of 2008

I, KENNETH DONALD SIMPSON, the Commissioner for Public Employment for the Northern Territory,

1. in pursuance of Section 14(2) of the *Public Sector Employment and Management Act*, and with reference to Section 43 of the *Interpretation Act*, revoke Determination Number 1 of 2007; and
2. in pursuance of section 14(2) of the *Public Sector Employment and Management Act* and with reference to section 13(a) of that Act, determine that the allowances specified in Column 1 of the Schedule, shall be payable at the rate shown in Column 2 of that Schedule, except that where permitted pursuant to a power under the Act or By-Laws, a Chief Executive Officer of an Agency has determined a rate in respect of a particular provision, that rate will prevail in that Agency.

This Determination is to have effect on and from 1 January 2008.
