DETERMINATION NUMBER 1062 OF 2022

Survey Interviewer

I, VICKI TELFER, Commissioner for Public Employment, pursuant to section 14(2) of the *Public Sector Employment and Management Act 1993* (the Act) and with reference to section 13(a) of that Act, determine that:

- 1. Survey Interviewer is an award free designation of the Northern Territory Public Sector for the performance of duties within the Department of Industry, Tourism and Trade.
- 2. Survey Interviewers will be employed for the purposes of conducting a survey of recreational fishers.
- 3. Pursuant to section 34A(1)(b) of the Act, a Survey Interviewer's duties, specified in the Schedule to this Determination, may only be performed by a person employed on a casual basis under section 29(3)(c) of the Act.
- 4. Pursuant to section 34A(3) of the Act, the terms and conditions of employment that apply to the designation of Survey Interviewer are as follows:
 - (a) The Survey Interviewer is employed as a casual;
 - (b) The Survey Interviewer is employed and paid by the hour on an as required, or as available basis;
 - (c) There is no continuing contract of employment with the employer requiring the Survey Interviewer to work on a subsequent occasion at a specified time;
 - (d) The normal hours of duty of a Survey Interviewer shall be those required to perform the duties specified in the Schedule and shall be agreed between the Chief Executive Officer and the Survey Interviewer;
 - (e) The minimum daily engagement of a Survey Interviewer is one hour;
 - (f) The time of ceasing employment may be stipulated at the time of engagement or on a least one hour's notice of cessation of the period of employment being given;
 - (g) The hourly rate of payment shall be paid equivalent to the base hourly rate of the Technical level 1 salary for a 38 hour a week non-shift worker, under the *Northern Territory Public Sector 2021 2025 Enterprise Agreement*, or a successor agreement, plus a casual loading of 25%;

- (h) The hourly rate in sub-clause 4(g) above shall be adjusted in accordance with salary increases in the Technical stream awarded under the applicable enterprise agreement;
- (i) As detailed in Schedule 1 of the *Public Sector Employment and Management Regulations 2011*, Parts 7 and 8 and section 59A of the Act do not apply to or in relation to an employee employed as a Survey Interviewer;
- (j) The *Public Sector Employment and Management By-laws* do not apply with the exception of:
 - i. By-law 32 (Vehicle Allowance) Survey Interviewers shall have access to vehicle allowance in accordance with By-law 32 when employed; and
 - ii. By-law 8 (Long Service Leave) which may apply to a long term casual employee with approval of the Commissioner;
- (k) All employment instructions issued by the Commissioner pursuant to Section 16 of the *Public Sector Employment and Management Act 1993* apply with the exception of Employment Instruction Number 6 – Employee Performance and Inability.
- (I) As a casual employee, a Survey Interviewer:
 - i. does not accrue or become entitled to utilise paid leave; and
 - ii. does not receive payment for public holidays not worked.
- 5. This Determination is to have effect on and from 1 January 2023.
- 6. This Determination will cease to have effect from midnight on 31 December 2027 unless revoked earlier.
