
DETERMINATION NUMBER 2 OF 2009  
AND REVOCATION OF  
DETERMINATION NUMBER 11 OF 2005

I, KENNETH DONALD SIMPSON, the Commissioner for Public Employment:

1. in pursuance of section 14(2) of the *Public Sector Employment and Management Act* and with reference to section 43 of the *Interpretation Act*, revoke Determination Number 11 of 2005;
2. in pursuance of section 14(2) of the *Public Sector Employment and Management Act* and with reference to section 13(a) of that Act, determine that the salary rates and allowances specified in the Schedules apply to the relevant employees; and
3. employees employed on the date of this determination are entitled to receive the payment of salary and the First Aid Allowance retrospective to the beginning of the first pay period commencing on or after 11 November 2007; and
4. payment of the other allowances listed in the Schedule from the dates specified in the Schedule .

This Determination is to have effect as if it had been signed on 9 February 2009.
