#### Public Sector Employment and Management Act

#### **REVOCATION OF DETERMINATION 24 OF 1993**

I, KENNETH DONALD SIMPSON, the Commissioner for Public Employment, in pursuance of section 14(2) of the *Public Sector Employment and Management Act* and with reference to section 43(a) of the *Interpretation Act*, revoke Determination Number 24 of 1993.

## **DETERMINATION NUMBER 3 OF 2009**

I, KENNETH DONALD SIMPSON, the Commissioner for Public Employment:

- in pursuance of section 34(1)(a) of the Public Sector Employment and Management Act (the Act), determine that duties specified in the Schedule may be performed for a fixed period by a person appointed on a temporary basis under section 29(3)(b);
- in pursuance of section 34(3) of the Act, determine that a person may be employed to perform duties for a period not exceeding 5 years;
- 3. in pursuance of section 34(4) of the Act, determine that the terms and conditions to apply to and in relation to the employment as a temporary employee shall be as follows:
  - a) Salary shall be in accordance with the provisions of the applicable Workplace Agreement made under the Workplace Relations Act, or a Determination of an Arbitral Tribunal.
  - b) An Employee shall give at least two weeks notice to the employer of termination of the contract.
  - c) The terms and conditions of employment are as detailed in the relevant Public Sector Employment and Management By-laws with the exception of By-law 29 Temperate Clothing Allowance which does not apply.
  - d) The following By-laws apply as if the employee were a permanent employee.
    - By-law 15, Emergency Leave
    - By-law 16, Special Leave Without Pay

- e) As detailed in Regulation 5 of the Public Sector Employment and Management Regulations, Parts 7 and 8 and sections 57 and 58 of the Act do not apply to or in relation to an Employee employed on a temporary basis.
- f) All Employment Instructions issued by the Commissioner in pursuance of section 16 of the Act apply to the Employee with the exception of:
  - (i) Employment Instruction Number 5 Medical Incapacity;
  - (ii) Employment Instruction Number 6 Inability to Discharge Duties; and
  - (iii) Employment Instruction Number 7 Discipline.
- g) The Employee shall retain accrued recreation leave, personal leave and continuity of service for the purpose of long service leave where there is no break in employment within the Public Sector.

This Determination does not apply to those employees to whom Determination Number 4 of 2009 applies.
