*Public Sector Employment and Management Act 1993***DETERMINATION NUMBER 1056 OF 2024**2022-2026 TERRITORY GENERATION ENTERPRISE AGREEMENT  
ALLOWANCE TABLE AMENDMENT

I, NICOLE HURWOOD, Commissioner for Public Employment, pursuant to section 14(2) of the *Public Sector Employment and Management Act 1993* and with reference to section 13(a) of that Act, determine, in relation to employees covered by the *2022-2026 Territory Generation Enterprise Agreement* (the Agreement) that:

1. The following allowances:
  - a. Availability Allowance (clause 57 of the Agreement)
  - b. Consolidated Disability Allowance (clause 58 of the Agreement)
  - c. Extra Duty – Group 2 – Call out Ratio (clause 59 of the Agreement); and
  - d. Team Leader Allowance (clause 65 of the Agreement)

in Schedule 2 of the Agreement have been increased in accordance with the provisions of clauses 57, 58, 59 and 65 and the updated salary rates in Determination 1020 of 2024.
2. The new allowance rates are set out in Schedule A to this Determination which are effective from 18 July 2024 and 17 July 2025.
3. This Determination takes effect on the date that it is signed.
4. In respect to an employee eligible for the allowances covered by paragraph 1, an employee who was employed on the date this determination is signed and who has worked between 18 July 2024 and the day immediately before this Determination is signed (the transitional period) is entitled to be paid an amount that is equal to the difference between:
  - a. The amounts already received, or purportedly received, in return for work performed during the transitional period, and
  - b. The amount they would have been entitled to be paid during the transitional period if the entitlement set out in paragraph 1 had come into operation on 18 July 2024.
5. This Determination will cease to have effect from the notional expiry date of the Agreement, or upon the date of effect of any successor enterprise agreement, whichever is the later.
