# The changes in Administrative Arrangements announced in September 2016 were implemented over the first part of the December quarter. For those Agencies that were not or were little affected by the changes, the December quarterly averages above reflect the full seven pays in the quarter. For the new Agencies the averages reflect only the last three pays, by which time the implementation was complete across the entire sector.
