**REVOCATION OF DETERMINATION 1045 of 2013**

I, CRAIG JOHN ALLEN, the Commissioner for Public Employment, in pursuance of section 14(2) of the *Public Sector Employment and Management Act* and with reference to section 43 of the *Interpretation Act*, revoke Determination Number 1045 of 2013.

**DETERMINATION NUMBER 1018 OF 2018**

I, CRAIG JOHN ALLEN, the Commissioner for Public Employment, in pursuance of section 14(2) of the *Public Sector Employment and Management Act*, and with reference to section 13(a) of that Act, determine that:

1. Employees who were at the Professional 1 (P1) and Professional 2 (P2) levels prior to 6 January 2011:
  - a) who translated to the restructured P1 or P2 classifications on 6 January 2011 under the NTPS 2010-2013 Enterprise Agreement; and
  - b) who have remained at their respective classification level since that date,shall have access to a grand-parenting allowance as set out in the attached Schedule, subject to paragraphs 2 - 4;
2. Employees who attain the highest increment point of their respective classification level under the NTPS 2017-2021 Enterprise Agreement (the Agreement), after satisfying the annual increment provisions contained in clause 21 of the Agreement, shall be eligible for the applicable grand-parenting allowance set out in the schedule;
3. The grand-parenting allowance will apply to employees who transfer to another job at the same classification level; and
4. The grand-parenting allowance will count as salary for all purposes.
