Overtime and Time Off In Lieu provisions for AO7/SAO1 employees
Tourism NT and Licensing NT

- I, Nicole Hurwood, Commissioner for Public Employment, pursuant to section 14(2) of the *Public Sector Employment and Management Act 1993* and with reference to section 13(a) of that Act, and with reference to clause 59.4(b) of the *Northern Territory Public Sector 2021 2025 Enterprise Agreement* (the Agreement), determine that:
- 1. Employees in the Department of Industry, Tourism and Trade employed at the Administrative Officer 7 (AO7) or Senior Administrative Officer 1 (SAO1) classification shall be entitled to time off in lieu (TOIL) or overtime payments in accordance with clauses 59 and 60 of the Agreement, provided that the employee occupies a position in:
 - (a) Tourism NT as listed in Schedule A and performs marketing and business event familiarisations and / or site inspections; or
 - (b) Licensing NT as listed in Schedule B and performs on-site visits and / or compliance activities to meet regulatory objectives.
- 2. Overtime payments will only be authorised where TOIL or other flexible work arrangements are unavailable or unable to be used.
- 3. The overtime was approved in advance by the Chief Executive Officer or delegate as applicable.
- 4. Payment for overtime will be at the maximum salary of the Administrative Officer 6 classification.
- 5. This Determination will cease to have effect from 1 June 2026, unless revoked earlier.
