Public Sector Employment and Management By-laws


**DETERMINATION NO. 9 OF 2005 AND
REVOCATION OF DETERMINATION NUMBER 2 of 2002**

I, JOHN DOUGLAS KIRWAN, the Commissioner for Public Employment, pursuant to the Public Sector Employment and Management By-Law 8(1), and with reference to section 43 of the *Interpretation Act*, revoke Determination No. 2 of 2002, dated 21 January 2002 and hereby determine:

- (a) Each employer of employees in the public service or public sector under an Act, as amended from time to time, of the Commonwealth, a State or another Territory of the Commonwealth, which Act is specified in Part 1 of the Schedule;
- (b) The public hospitals under an Act, as amended from time to time, which Act is specified in Part 2 of the Schedule, and which public hospitals are recognised by the Chief Executive Officer of Territory Health Services;
- (c) Each of the body corporates specified in Part 3 of the Schedule;
- (d) The Australian Defence Force as the employer of persons engaged as members of the Australian Defence Forces; and
- (e) "Public employer" as defined in the *Public Sector (Mobility) Act*,

to be recognised employers.


