This report:

- shows the NTPS quarterly staffing average by agency, and who funds those FTE. 'NTG Funded' is the average FTE that are funded by the NT Government. 'Ext. Funded' is the average FTE that are funded by external sources, such as the Commonwealth Government.
- shows the quarterly change in average staffing FTE by agency between the current and previous quarter.

NOTES:

- Due to the reduction in the number of agencies resulting from the October 2020 machinery of Government changes, yearly agency comparisons won't be undertaken until June 2022.
- Table shows totals for paid full-time equivalents, including casuals and excluding Board Members, averaged over all pays in the stated quarter.
- Results are represented as whole numbers for ease of reading, with rounding performed at the last stage of calculation for maximum accuracy. Values from X.00 to X.49 are rounded down and values from X.50 to X.99 are rounded up.
